Bill Dodge confirmed that all the club fuel is sold with no plans for an additional fuel order until spring.

Bill also reported that he had started runway crack repairs but further work is on hold due to lack of repair materials.

Joel Hebert reported on the KCSO deputy now residing at the Park entrance. Don Hammond, phone number 385-5784. Don has found "pot" pots and meth –cooking debris in the park. Scott Anderson cautioned all to back off and call the authorities if suspicious activity is noted.

A motion was made and seconded for the club to pay for the meals of all members at the January banquet. The motion failed.

There was discussion of having the January banquet in Knox County and inviting Doug Bataille and appropriate members of his staff.

There was discussion of Christmas turkeys for the neighbors at the flying field. There was no support.

There was discussion of a turkey for Christmas for the KCSO deputy. That idea did receive support.

Scott Anderson reported on the Night Fly at House Mountain last weekend. Paul Funk buddy-boxed a group of Boy Scouts before dark and gave rides in a Piper Pacer. There were about 10 pilots registered for the Night Fly. Scott reported that there were some interesting aircraft of interesting

configurations. All aircraft were well illuminated and the flying went well.

Phil Spelt initiated a discussion of trying to tie KCRC in with some local Scout troops for aviation ground school and buddy-box flying. Involvement in the AMA TAG (Take Off And Grow) Program was also brought up. Phil is going to investigate the TAG requirements. A motion was made, seconded, and approved to grant Phil authorization to interface with AMA concerning the TAG program.

Scott Anderson reminded everyone of the Hangar Fly at TACAir on Nov. 11 at 6:30 PM.

In view of the leftovers from the Heli Fly-In, it was decided to have a picnic at the field on Nov. 13.
